The SEIAA, in its meeting held on 25/08/2025, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for grant of EC under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in Annexure (2).
- 7. The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Environment Impact AssessmentAuthority(SEIAA) Appraisal Committee hereby decided to grant EC for instant proposal of M/s. Mr. Cyrus Mody under the provisions of EIA Notification, 2006 and as amended thereof.



1.1	After detailed deliberations with the PP and their accredited consultant, SEAC-2 decided to recommend the proposal for increased height of 139.95 meters as per HRC NOC obtained by the PP on 15.12.2023. The other conditions stipulated in earlier SEAC-2 minutes and ECs will remain unchanged. The project was considered for appraisal on 24 th February 2025 and minutes of the meeting have been recorded as above. From the website of Hon'ble Supreme Court in Writ Petition (Civil) and the news item appearing in various newspapers on 25.02.2025, the MoEF&CC Notification dated 29.01.2025 has been stayed and Status Quo has directed to be maintained. Your Proposal was considered in 303rd meeting of State Level Environment Impact Assessment Authority (SEIAA) held on 25th August, 2025 and SEIAA decided to grant amendment in Environment Clearance dated 11.04.2023. The amendment of proposal is as below-

The proposal was initially considered by SEIAA in its 257th meeting and decided to grant EC with restricting to the height of 120 meters as PP was not obtained HRC NCO. Now PP submitted HRC NOC vide No. CHE/HRB-983/DPWS dated 15.12.2023 for height of 139.95 m. After deliberation SEIAA decided to release of height as per received HRC NOC dated 15.12.2023, subject to all other terms and condition mentioned in earlier EC dated 11.04.2023 shall remain same
